1 Preface

- 1.1 Hungarian Forest Certification Non-profit Ltd was established in order to develop and operate a forest certification and forest based product certification scheme: the Hungarian Forest Certification.
- 1.2 Hungarian Forest Certification Non-profit Ltd is legally representing the Hungarian Forest Certification, which is developed and operated according to its written rules and procedures described in Chapter 3 in this document.
- 1.3 Hungarian Forest Certification aligns itself from mission through principles to requirements with PEFC (Programme for Endorsement of Forest Certification schemes) certification, and seeks for endorsement.
- 1.4 In Hungary, Hungarian Forest Certification Non-profit Ltd is acting on the PEFC Council's behalf as PEFC authorised body, based on an administration contract signed with the PEFC Council in accordance with PEFC GD 1004:2009.

2 Mission statement

- 2.1 The primary objective of the Hungarian Forest Certification Non-profit Ltd is to develop and operate a forest and forest-based product certification that meets the international requirements of PEFC.
- 2.2 It shall make all efforts to maintain a relationship with its direct partners and those indirectly concerned including the natural environment that is based on responsibility for its actions, the protection of universal human values and the sustainable use of the environment.
- 2.3 The development and operation of the Hungarian Forest Certification shall be based upon the principles of sustainability, participation, consensus, transparency, continuous improvement and independent accreditation and certification.
- 2.4 In addition to scheme development and operation, the Hungarian Forest Certification Non-profit Ltd is dedicated to the promotion of forest products, and in particular forest wood products and processed wood products.

3 Scheme description

- 3.1 When endorsed, Hungarian Forest Certification and PEFC apply mutual recognition of certificates.
- 3.2 The HFC scheme is written in English. Translations of the document can be provided by the Hungarian Forest Certification Non-profit Ltd. In case of any doubts the English version is decisive.
- 3.3 The scheme is divided to separate documents, but shall be applied as one single set of rules and requirements with all amendments.
- 3.4 The scheme is being assessed by the PEFC Council before endorsement and accepted as fully compliant with the PEFC Council's requirements. In case of any doubts or inconsistencies, PEFC Council's requirements overrule the Hungarian Forest Certification scheme.
- 3.5 According to 1.4. technical changes in the PEFC Council's requirements directly and immediately apply to the Hungarian Forest Certification without further action.
- 3.6 References to various documents always refer to their latest version published at www.pefc.hu, www.pefc.org, or iso.org etc. due regards to their transition periods.
- 3.7 Hungarian Forest Certification adopts the following PEFC documents as part of its scheme:
 - a) PEFC ST 2001:2020 PEFC Trademarks Rules Requirements
 - b) PEFC ST 2002:2020 Chain of Custody of Forest and Tree Based Products Requirements
 - c) PEFC GD 2001:2022 Chain of Custody of Forest and Tree Based Products and Related Standards Guidance for Use
